Dear Law Student:

The Garden State Bar Association (GSBA) cordially invites you to apply to be one of our 2019 Scholarship Recipients. The Scholarship will be awarded on Saturday, June 15, 2019 at our 44th Annual Scholarship & Awards Gala.

The GSBA was created to support African-American and other attorneys of color to gain and maintain permanence in the legal profession in the State of New Jersey. In an effort to give back to the community, more than twenty-five (25) years ago, the GSBA created a Scholarship Fund to help African-American law students attending schools in New Jersey. Traditionally, one student from each of New Jersey's law schools was chosen to receive a scholarship. However, the GSBA has expanded the scholarship program to permit New Jersey residents attending law schools outside of New Jersey to apply.

In order to apply for the scholarship, applicants must meet the following criteria:

- Currently enrolled in a New Jersey law school or be a New Jersey resident enrolled in an accredited law school in another state;
- A full-time first or second-year student, or a part-time first, second or third-year student (May 2019 graduates are not eligible);
- In good academic standing (an official certificate of good standing must accompany the application);
- Demonstration of financial need;
- Significant involvement in law school and community activities that benefit the African-American community;
- Submission of a Scholarship Application;
- Submission of a current resume;
- Submission of an official Certificate of Good Standing;
- Submission of Biography (no more than a single page); and
- Official sealed copy of current Law School Transcript, postmarked no later than March 8, 2019, to be mailed to: Sobande F. Afolabi, Esq., c/o GSBA Scholarship Committee, 48 Allen Street, Irvington, NJ 07111.
- Except for Official Law School Transcript, application materials must be emailed in PDF format to 2019gsbascholarship@gmail.com as one submission and received no later than March 22, 2019 at 11:59pm EST. Applications received after this date will not be considered. DEADLINE HAS BEEN EXTENDED TO FRIDAY, APRIL 5, 2019. ALL MATERIALS, INCLUDING TRANSCRIPT, MUST BE RECEIVED BY APRIL 5, 2019.

• Tentatively, required interviews with the Scholarship Committee will be scheduled for the week of **April 8, 2019**.

In addition to the above, all applications will be judged based upon their content, clarity, ability to follow directions and professionalism. It is our intent to award at least three scholarships. However, the Scholarship Committee reserves the right to award more or less scholarships based on the amount of funding available and/or strength of applicants' submitted materials.

All applicants will receive a confirmation email acknowledging receipt of your application materials and law school transcript.

All successful scholarship recipients will be notified by email and regular mail on or before **April 30, 2019**. Please be advised that each scholarship recipient will be expected to attend the GSBA's 44th Annual Scholarship & Awards Gala on June 15, 2019 as a guest of the GSBA.
